1. **Be It Resolved** that Bylaw 11 - Fourth Estate Independence be struck out effective immediately from the Bylaws of the Society.

2. **Be It Resolved** the current elected Directors on the Board be removed immediately and a new election for the Board of General Purpose be reheld immediately.

Be It Further Resolved Nominations for the 6 Board of Directors positions be opened from the floor immediately

Be It Further Resolved voting shall be only by show of hands and no roll call vote allowed

3. **Whereas** the Society is a registered society under the Societies Act of British Columbia; and

Whereas the members of the Society have determined that it is in the best interest of the Society to voluntarily dissolve;

Be It Resolved the Society be voluntarily dissolved pursuant to Section 125 of the Societies Act of British Columbia.

Be It Further Resolved the Directors of the Society be authorized and directed to:

a. Satisfy all debts and liabilities of the Society.

b. Distribute any remaining assets of the Society in accordance with the Society’s bylaws and the Societies Act of British Columbia.

c. Transfer any funds and assets of the Society, remaining after the satisfaction of its debts and liabilities, to the Kwantlen Student Association.

d. File the necessary documentation, including Form 10 (Application for Dissolution) and the Notice of Special Resolution with the British Columbia Registrar of Companies.

e. Take any other actions required to effect the dissolution of the Society.

Be It Further Resolved the dissolution of the Society shall be effective on the date the Registrar of Companies issues a certificate of dissolution.

4. **Whereas**, the members of the PIPS has determined that certain records are no longer necessary to retain and have fulfilled all legal, regulatory, and organizational requirements for retention;

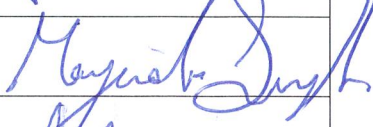
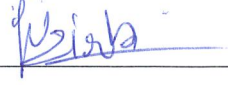
